Discover Scuba Liability Release and Assumption of Risk

Please read carefully before signing.

I, (Participant Name) _____, hereby affirm that I have been advised and informed of the inherent hazards of scuba diving. I understand that diving with compressed air involves certain inherent risks; decompression sickness, embolism, or other hyperbaric injuries can occur.

I understand and agree that neither my instructor(s), Russell Younger / PADI Staff member, the facility through which this experience is offered, Inland Divers Supply, nor International PADI, Inc., nor any of their respective employees, officers, agents, or assigns (hereinafter referred to as "Released Parties"), may be held liable or responsible in any way for any injury, death or other damages to me or my family, heirs, or assigns that may occur as a result of my participation in this experience or as a result of the negligence of any party, including the Released Parties, whether passive or active.

In consideration of being allowed to participate in this experience, I hereby save and hold harmless said program and I personally assume all risks in connection with this experience, for any harm, injury or damage that may befall me while I am a participant in this experience, including all risks connected therewith, whether foreseen or unforeseen.

I also understand that scuba diving is a physically strenuous activity and that I will be exerting myself during this experience, and that if I am injured as a result of heart attack, panic, hyperventilation, etc., that I assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I understand that the Discover Scuba Experience is designed to provide me with an introduction to scuba diving in a pool environment. The experience is not intended to train me as a competent diver. I further understand and agree that I must be thoroughly instructed in the use of scuba in a certification course under the direct supervision of a qualified instructor to become a certified, competent diver.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian. I understand that the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act.
